CEO'S MESSAGE

2023 saw some interesting shifts in the way that India and as a consequence Indian business houses, lawyers and Institutions are perceived globally. There is a frantic push to understand and engage with the Indian legal community given the favorable economic macros and political stability India has demonstrated in an otherwise extremely challenging global environment.

From inception, MCIA has been holding roadshows across the world, and while there has always been support and interest in our activities, we were largely clubbed with the 'emerging markets' bucket. Over the past year however, we have seen a stark difference; every jurisdiction that MCIA has held roadshows in has seen focused interest in India, with often multiple events surrounding an India only theme. This has also reflected in a jump in interest and participation at our annual flagship event - India ADR week.

As India's premier arbitral institution, we are duty bound to ensure consistent, transparent, and effective case administration to a standard that is acceptable internationally. To that extent, MCIA's growth this year has been on par with last year in terms of new case filings, with a total value in excess of Rs. 300 crores.

Our commitment to diversity stands with women arbitrators making up 47% of all arbitrator appointments in 2023. Emergency arbitrations that have been filed under the MCIA Rules, have been completed within 14 days, and upheld when challenged in the courts. We have ensured consistency of output with 93% of all arbitrations completing within 18 months, with none being set aside by the courts - the same as the previous year.

The MCIA has always pushed to build a broader eco system for arbitration in India, and to that effect, the MCIA launched the tribunal secretary program this year. The program saw an overwhelming response, and we hope to encourage the practice of appointing tribunal secretaries in matters that deem it fit.

2023 has been an extremely encouraging year, and through this report you will find details our progress.

HIGHIGHTS

MCIA received 23 new matters in 2023, of which 87 % were from matters where both parties were domestic and 13 % from matters where either or both parties were international.

95% of the MCIA administered matters arose from contracts containing an 'organic' MCIA Arbitration clause

Keeping with our commitment to diversity, 47% of all arbitrators appointed by MCIA are women.

MCIA received its 3rd Emergency Arbitration Application in 2023. As stipulated under the MCIA Rules, an order was passed in less than 14 days from the date of application

The third annual India ADR Week 2023 was held between 9th to 14th October 2023. The week witnessed 37 sessions across three cities; Bengaluru, Mumbai and Delhi. It saw the confluence of leaders from across the world in arbitration, mediation and ODR.

MCIA conducted its first Tribunal Secretary Training Program in Mumbai and Delhi during the India ADR Week, 2023. This was a first of its kind in India, which witnessed the participation of young practitioners and trainers from around the world for the two-day Program

In furtherance to MCIA's commitment to strengthen and promote ADR around the globe, MCIA organised road shows in 5 jurisdictions; London, Paris, Singapore, Germany and Japan

Young MCIA continues to promote ADR among young practitioners through different initiatives. The YMCIA Steering Committee was announced for the term 2023-2025







INTERNATIONAL COMMERCIAL ARBITRATION: THE DAWN OF A NEW AGE Ahmedabad, 22 April 2023

MCIA in collaboration with Gujarat High Court Arbitration Centre and Gujarat High Court Advocates' Association organised a full day conference on International Commercial Arbitration in Ahmedabad on 22 April 2023 at Hyatt, Ahmedabad.

The event consisted of a plenary session, followed by four sessions revolving around Arbitration.

Hon'ble Mr. Justice M.R. Shah (Retd.), Judge, Supreme Court of India, Hon'ble Mr. Justice A.J. Desai, Former Acting Chief Justice, Gujarat High Court, Kamal Trivedi, Advocate General of Gujarat High Court and Devang Vyas, Additional Solicitor General, Gujarat High Court graced the occasion with their presence.

The event witnessed an overwhelming response of more than 200 participants including former Judges of the Supreme Court, sitting and former Judges of the Gujarat High Court, Senior Advocates, international counsels and arbitrators, advocates from Gujarat, quantum valuation and technical experts, engineers and surveyors, chartered accountants, technology service providers in arbitral proceedings, and enthusiastic young practitioners and students.













INDIA ADR WEEK 2023 Bengaluru, Mumbai and New Delhi, 9-14 October 2023

The MCIA organised the third India ADR Week in 2023, an event spread over 6 days (October 9-14, 2023), and across 37 sessions in Bengaluru, Mumbai and New Delhi. This was the first in-person edition of the IAW, which witnessed sessions commencing from 8 a.m. till 7:00 p.m. followed by drinks and dinner.

The event saw a participation of over 700 participants and 35 Indian and International law firms. The week was supported by over 30 organisations. The inaugural message was delivered by Zia Mody, Founder and Managing Partner, AZB & Partners, and Mr. Constantine Partasides, King's Counsel, Partner, Three Crowns LLP.

The Debate by YMCIA was on 'Confidentiality is the biggest roadblock to legitimacy of the arbitral process'. This was followed by Drinks and Dinner.




