

CEO's MESSAGE



2024 has been a year of stellar growth at the MCIA.

The number of new cases filed with the MCIA grew by 48% over the previous year, with 98% of these cases originating from a contract with an 'organic' MCIA clause. We also hit an important threshold of 100 cases filed since inception, a feat few arbitral institutions have been able to achieve within 8 years of establishment.

While we remain headquartered in Mumbai, we now consistently see parties from across India and the globe adopting MCIA clauses, not just on an ad hoc basis, but as standard across multi jurisdictional contracts.

This has demonstrated that we have been able to earn the trust of parties, consistently resolving disputes in a timebound, transparent and cost efficient manner. To this end, I am very happy to share that like the previous year, this year has seen 91% of awards delivered within 18 months, with none being set aside by a court of law. In fact, in a landmark ruling, the DIFC Court enforced an MCIA arbitral award.

The MCIA's growth, efficiency and consistency has been a product of the MCIA Council's commitment to building a truly world class arbitral institution in India. I am happy to share that we have expanded the MCIA Council welcoming 13 new members from India and across the globe. I am confident that the new Council will continue to build upon the foundation laid over the past 8 years.



MCIA HIGHLIGHTS



MCIA witnessed a **48% increase** in caseload. **34 new matters** were received, which are currently being administered under the MCIA Rules.

91% of MCIA administered matters arose from contracts containing an 'organic' MCIA arbitration clause.

MCIA expanded the MCIA Council to **25 members**. We are delighted to welcome **13 new** members.

MCIA announced Public Consultation of the Draft MCIA Arbitration Rules, 2024 (3rd Edition). The Draft Rules can be accessed on the MCIA website.

Keeping with our commitment to diversity, **1 in every 5 arbitrators** appointed by MCIA is a woman.

In a landmark ruling, the DIFC Court enforced an MCIA arbitral award.

The fourth annual India ADR Week 2024 was held between 23rd to 28th September 2024. This edition witnessed registrations of over 600 participants from different parts of India and from around the world. The week consisted of over 30 sessions spread during the Week in Bengaluru, Mumbai, and Delhi, with 160 speakers. The Inaugural IAW Cricket Match was held on 28th September 2024.

MCIA conducted its second Tribunal Secretary Training Program in Mumbai and Delhi during the India ADR Week, 2024. **22 participants** enrolled and participated in the Program with **20 experienced professionals** from India and abroad as faculty members.



ADR WEEK 2024



Bengaluru, Mumbai and New Delhi, 23-28 September 2024

The MCIA hosts the India ADR week every year, bringing together the brightest minds from across the world of disputes to India. The purpose of the IAW is to showcase India as a favorable jurisdiction for dispute resolution as well as to bring to light issues related to different sectors.

The MCIA organised the fourth India ADR Week in 2024, an event **spread over 6 days (September 23-28, 2024), and over 30 sessions in Bengaluru, Mumbai and New Delhi.** The sessions commenced from 8 a.m. till 7:00 p.m. followed by drinks and dinner.

600 Participants 20 Law Firms 30 Organisations 160 Speakers

The event saw a participation of over **600 participants** and over **20 Indian and International law firms**. The week was supported by over **30 organisations**. **160 speakers** participated in the sessions during the week.

The week kickstarted in Bengaluru with sessions organized on shareholder disputes, future of ODR mechanisms, strengthening Bengaluru as a destination for dispute resolution. Hon'ble Mr. Justice S.R. Krishna Kumar, Judge, High Court of Karnataka delivered the Keynote address.










INDIA ADR WEEK 2024








MCIA at Delhi Arbitration Weekend






'Navigating AI – Risks, Regulations and Legal Implications' organized by Indo-American Chamber of Commerce, MCIA & KPMG








YMCIA Supported the 4th AZB-GLC National ADR Triathlon










MCIA and CIArb India Collaboration

For the Singapore Convention Week 2024, MCIA was part of 2 sessions during the week.






Germany


