

MCIA Annual Report 2017 - 2018

As the MCIA completes 2 years on the 8th of October 2018, we are excited to share with you the steps we have taken to establish ourselves as a world class arbitral institution, and update you on our journey towards building an ecosystem for arbitration in India.

A snapshot of the activities undertaken by the MCIA over the last year is set out below.





The MCIA 2nd Annual Conference

The MCIA 2nd Annual Conference was attended by over 250 delegates from over 10 jurisdictions. We had 6 sitting judges in attendance, including the Chief Justice of India and the Chief Justice of the Bombay High Court.

We are happy to report that once again our conference was lauded for the quality of the speakers and presentations as well as the strict adherence to time lines. As before, the event received significant media coverage in India and elsewhere.

















Bombay High Court Order

Another first was the Bombay High Court's direction that an ad hoc arbitration conducted by an arbitrator that it appointed pursuant to section 11 of the Arbitration & Conciliation Act, 2015 (Mr. Rohit Gupta, Counsel Bombay High Court) be conducted in accordance with the MCIA Rules.

We are extremely pleased that after the Supreme Court's direction last year for MCIA to appoint an arbitrator, the Bombay High Court has reposed faith in this manner in the MCIA (and it's Council). It is the first case that we are aware of where a High Court in India has directed that an ad hoc arbitration be run in accordance with the rules of an institution. While it raises interesting jurisprudential issues, we are waiting to see if this becomes a trend in the future.





APRAG Membership

The MCIA is happy to report that our application to be included as a member of the Asia Pacific Regional Arbitration Group (APRAG) has been accepted and MCIA is now a part of the APRAG group of institutions.

MCIA is grateful to our Council member, Prof Michael Pryles, for suggesting that we do so. We are exploring the possibility of hosting the annual congress of APRAG in Mumbai.

MCIA - CIArb Training Programs

The MCIA and CIArb (India) have entered into an agreement to run training programs in Mumbai for CIArb courses:

- CIArb Certificate Course for Associate Grade was conducted on the 24th and 25th of February 2018 and again on 4th and 5th of August 2018.
- CIArb Certificate Course on Contract, Tort and Evidence was conducted on the 5th and 6th of March 2018.
- CIArb Certificate Course on International Arbitration for becoming an MCIArb was offered on 9th June, 10th June and 7th July 2018.
- The training for FCIArb was conducted on 4th, 5th, 11th and 12th of August 2018.
- The Award Writing Training was conducted on 13th and 14th of October 2018.
